Explanation for Proposed Change

The IJOC and EO propose to have this article reviewed. This change is required in a growing professional environment and to ensure that the reimbursement of costs and "per diem" allowance is matching the raised standards and expectations towards officials.

The proposal includes differences between level of shows and differences in responsibilities (tied also to the function and the level of the shows)

This change is to be combined with two other important changes:

- Increase of the entry fee (see separate proposal for entry fees submitted by EO) also needed to cover increased organizational costs due to inflation rates since the last increase years ago.
- Creation of an evaluation system « on the field » for officials

The proposal includes minor changes for the lower and lowest level events and has a bigger impact for the top level events (because of responsibility, accountability and workload).

At the same time we ask the FEI to take care of the pay-outs according to the new grid for the officials that are appointed by FEI (foreign judge and foreign steward).

IJOC

In the first phase of the Rule Revision Process earlier this year, the IJOC and EO proposed together a modification to the remuneration of Officials. This change is required in a growing professional environment and to ensure that the reimbursement of costs and "per diem" allowance is matching the raised standard, additional workload (preparation of events and reporting after events) as well as the increased cost of living during the past few years (more than 20% inflation since last change).

Based on discussions with different stakeholders, we are encouraged to note the two guiding principles embedded in our proposal have been accepted by the equestrian community.

- Differentiation between roles (coordinating and operating officials)
- Differentiation between level of shows

We took onboard the feedback from some stakeholders that the proposed per diem for the highest level events appear to be too high.

Therefore, we have re-examined our proposal and have developed a modified solution. We believe the modified proposal would be financially acceptable to organizers and to athletes. We remain open to discuss other items in the future that are sensitive and important such as an Officials evaluation system. This proposal is a stepstone in the path to professionalism. Specifically for the highest level events, we are convinced that next steps are to be discussed and reviewed in the near future.

In our modified proposal we make a clear distinction between the lowest level events and all other events.

Last but not least, we emphasize for the past 20 years the remuneration levels for Officials have not changed. At the 2018 Sports Forum nearly an entire day was devoted to the role of officials, including remuneration. The 2019 remuneration proposal was withdrawn due to the Covid-crisis and to help the organisers and athletes during those challenging times. Now the time has come to address the urgent needs raised nearly five years ago.

New proposed wording:

6.2.1.5. Per Diem (Daily Allowance) for all Officials except for the Technical Delegate

A per diem allowance according to the table below (giving the amount per day per official) must be offered to all FEI Officials during the period of the Event. This remuneration for miscellaneous costs is to be provided net after relevant (deductible) taxes (eg VAT) being borne by the OC. Direct income taxes to be borne by the Official when applicable. A per diem will be paid in addition for a maximum total of one travel day if the Official's travel day(s) is/are different from the officiating days.

For events running at the same time at the same venue, the valid per diem is the highest star level.

The amounts stated in the table are minimum amounts in Euro.

6.3. For expenses at other FEI Championships, FEI World Cup™ Finals, FEI Nations Cup™ Finals and Olympic Games see the specific rules for these Events. Expenses at Regional Championships and Regional Games are left to the discretion of the OC. For the "Per Diem" allowance, same principals according to the level of the event are applicable as in article 6.2.1.5

EEF

The EEF is opposed to the proposed increase in per diems for Jumping officials as it is considered to be too drastic. An increase is, in principle, ok but not in such amounts and not without a link to better quality of officials.

NF FRA

We can agree on a certain increase but not in this proportion which is too extreme and would lead to side effects in order to ensure financial sustainability of shows.

We agree on differentiating amounts based on level of shows, due to their very different reality.

To be agreed on with wider consultation of stakeholders.

NF GER

On the basis of general inflation and price adjustments, the proposals are understandable in principle. Also in our view, the differentiation according to duty/position as well as to category of Event is a plausible approach. The per diems of Official have to be adapted in a certain regular turn. In its entirety, however, this cannot be borne by the OCs alone.

From the Organiser's view, the situation looks a bit different than from the Officials' point of view. In the way it is proposed, the remunerations (excluding travel and hotel costs) for example for a CSI2* would increase from about 4,300 € today to about 7,500 € in future.

Mandatory costs for an OC have also increased considerably during the last years, e. g. by stricter biosecurity rules of the FEI (organised check-in with veterinary control on the arrival day, provision of isolation boxes, etc.). The price increases of 20 % over the last 8 years affect the Organisers to the same extent as all other persons and organisations. Also for the products and services that make an Event possible at all, nowadays more money must be paid than in the past and this reduces the financial leeway of every Event.

Thus, an adjustment of per diems can only be done in a moderate way with lower amounts than the ones proposed (an increase of far more than 150~% for CSI4*/5* cannot be justified with the general price increase) and with additional measures to reduce costs.

The IRL NF would like to voice their support for a review of this article and support the commitment to have a consultation on this.

NF ITA

<u>We definitely do not agree to the per diem table</u> (Daily Allowance) for all Officials submitted by the IJOC.

NF MEX

We are not against ensuring that the "reimbursement of costs and "per diem" allowance matches the raised standards and expectations towards officials" but the proposed increase is out of proportion. Officials had been receiving 120 euros per day for several years now and we support the idea of increasing the amount, but 400 euros per day is an increase of more than 200%.

The increase should reflect the economic reality of the global inflation rate.

NF NED

We understand the need to make changes to the expenses for these officials but find the suggested amounts quite high. All these extra cost will eventually be charged to either athletes or others by the organizers. Interested to see what the 'wider consultation' will entail.

NF NOR

We do not agree in the proposed per diem table for officials at jumping events. We agree in making a differentiated per diem, based on the type of event and the function/role of the official. However, we think the proposed increase in the per diem is too extensive from one year to another. We therefore suggest that the amount is considered again. It would be of great interest and help if the proposal could include some ideas of suggestions regarding how to finance such an increase of the per diem.

NF SWE

The SWE NF do not support IJOCs proposal of per diem. We do understand the rationale behind the proposal but an increase from 120 Euro per day to 400 Euro per day is not acceptable at the moment, due to increasing costs and inflation. In the end it is the competitors and their Horse Owners who has to pay. We propose a gradual increase and support the FEI Jumping Committees proposal of a wider consultation in order to find an agreement.

FEI feedback

In consultation with the International Jumping Officials Organizers and the Equestrian Organizers, is as follows and that these minimum per diem charges only apply for Europe and North America.

For the rest of the world the current Rule remains applicable.

6.2.1.5.6. Per Diem (Daily Allowance) requirements in other regions for all Officials except the Technical Delegate

A per diem allowance of minimum 120 Euros per day per Official must be offered to all FEI Officials during the period of the Event. This remuneration for miscellaneous costs is to be provided net after relevant taxes being borne by the OC. A per diem will be paid in addition for a maximum total of one travel day if the Official's travel day(s) is/are different from the officiating days.

For the avoidance of doubt, all references to CSI5* and CSIO5* Events in the paragraphs below (Art. 200.8) include CSI5*-W and CSIO5*-W Events.

The dates of all CSI5* and CSIO5* Events shall be approved by the FEI Secretary General two years prior to the year in which the Event is to take place; the dates of all other higher level Events (all Events except for those listed as CIMs in GRs Appendix E), shall be approved by the Secretary General the year prior to the year in which the Event is to take place.

Consequently, the following deadlines apply in relation to Events to be inserted in the FEI calendar:

- Applications for all CSI5* and CSIO5* Events must be received by the FEI Secretary General by 1 October two years prior to the year in which the Event takes place.
- Applications for the dates of all other higher level Events (Events that are not listed as CIMs in GRs Appendix E) must be received by the FEI Secretary General by 1 October the year prior to the year in which the Event takes place.
- Applications or modifications for higher level Events that arrive after the above deadlines are considered as late date applications or modifications and may only be considered by the FEI if received at least 12 weeks prior to the start of the Event.
- Applications or modifications for CIMs (including CSI2* Open Events) must reach the FEI Secretary General no later than four weeks prior to the start of the Event, with the exception of applications or modification for CSI2* Events with Longines Ranking Competitions, which must reach the Secretary General no later than nine weeks prior to the start of the Event.

For late date applications and/or modifications of Events please refer to the provisions of GRs Art. 112.7.

Explanation for Proposed Change

Upon request of the Commercial and Legal departments of the FEI.

Proposed Wording on 6 July 2022

3. A sponsored obstacle is any obstacle inside the flags of which there is advertising material or a sponsors product or representation of a product. If advertising material or representation of a product on the wing of an obstacle is more than 0.50 m^2 , the obstacle is also considered to be a sponsored obstacle. If the wings of an obstacle have advertising of 0.50 m^2 or less, the obstacle is not considered a sponsored obstacle.

For FEI-Named Events and other Events or Competitions as designated by the FEI, the number of sponsored efforts shall be decided by the FEI in accordance with the FEI Sponsored Obstacles Guidelines. At the FEI World and Continental Championships, FEI World Cup™ Final, FEI Nations Cup™ Final and other Events or Competitions as designated by the FEI, no more than 30%, rounded up to the next whole number of the efforts, may

be sponsored obstacles. The Technical Delegate must approve the design and construction of all obstacles with regard to safety and technical suitability.

In agreement with the Chair of the Jumping Committee, FEI Commercial Director and FEI Director Jumping, the number of sponsored efforts may be increased up to 50%. This number may be increased to 75%, pending approval of the FEI Jumping Committee of the design of the additional 25% of sponsored efforts.

NF GER

Such a rule could create conflicts with national TV stations or EBU who have their own rules with regards to maximum number and appearance of sponsored obstacles. What would be the benefit and purpose of such a rule?

Keep the present wording.

NF USA

The USA NF believes that the FEI Sponsorship Obstacle Guidelines should be outlined prior to these specifications being removed from the Rules. Additionally, given that FEI Named Events covers all of the FEI sponsored events, 'competitions as designated by the FEI', could be removed.

FEI feedback

If there are national TV rules, they will prevail on FEI rules.

Explanation for Proposed Change

There have only been two months of application of this new regulations.

Concerning the time faults per second, there is currently no idea of how this will affect the competitions. By indicating this here, we kindly ask for the possibility to evaluate this rule.

Art. 234 SPEED

- 1. The speeds for international Competitions are as follows:
- 1.1. 350 325 m per minute minimum and 400 m per minute maximum. In indoor arenas the speed may be reduced to 325 m per minute; the speed may also be reduced to 325 m per minute in outdoor arenas providing it is stated in the Schedule.
- 1.2. Puissance / Power and Skill Competitions: no minimum speed required.
- 1.3. Longines Ranking Competitions counting for Longines Ranking point groups AA through D at CSIs and CSIOs: 375 m per minute minimum and 400 m per minute maximum outdoors and 350 m per minute minimum indoors. In outdoor arenas measuring $65 \text{ m} \times 85 \text{ m}$ or smaller the speed may be reduced to 350 m per minute.
- 1.4. Longines Ranking Competitions counting for Longines Ranking point groups E at CSIs and CSIOs: 350 m per minute minimum and 400 m per minute maximum.

1.4.5. Nations Cup: 400 m per minute for 5* and 4* Nations Cup Competitions outdoors; 375 m per minute for 3* and 2* Nations Cup Competitions outdoors, 350 m per minute for 1* Nations Cup Competitions outdoors and also for all indoor Nations Cup Competitions. 1.5.6. Young Horse Competitions: 325 m per minute minimum.

NF IRL

The IRL NF note the proposed changes to Article 234 Speed by the FEI but would like to comment that the results should be recorded in faults and time, not just time added to the faults to achieve the final score

FEI feedback

The FEI is implementing the possibility to display Penalties for Faults at the obstacles and time Penalties separately in the FEI database. This will be communicated to timing providers and should be launched by the end of this year.

Explanation for Proposed Change

It appears that bleeding from one or two nostrils is not covered in current regulations. This was obvious at the last Olympics in Tokyo when an Athlete fulfilled the jumping course despite heavy nose bleeding from the horse and should of course had been stopped by the

Judge during the ride and eliminated since the horse was clearly unfit to continue the competition (if a regulation had been in place).

Nose blood can occur from bleeding in upper and/or lower airways (in racing horses not unusual with even lung bleeding, Exercise Induced Pulmonary Haemorrhage, EIPH, but usually after exercise).

To distinguish from a suspected minor bleeding due to a small laceration of a nostril, the horse should be checked by an FEI Veterinarian after the ride.

Nose blood should be a reason for elimination because of the impact on Horse welfare, but also for general perception, i.e., Social License to Operate (SLO).

4. The President of the Ground Jury (or in the absence of the President of the Ground Jury from the Ground Jury box, the Ground Jury Member designated by the President of the Ground Jury to take over the running of the Competition in their absence) may, in their sole discretion, ring the bell (or instruct another Ground Jury member to ring the bell) to eliminate an Athlete/Horse combination while a round is ongoing if the President of the Ground Jury (or their designee) decides that it would be contrary to the principles of horse welfare to allow the combination to continue the round. The decision to eliminate is final and not subject to appeal or protest.

4.5. Elimination is left to the discretion of the Ground Jury in the following cases:

IJRC

The IJRC agrees with the Jumping Committee that believes that a broader concept (going beyond just the relatively rare case of blood in the nostrils) is needed in order to give the Ground Jury the clear authority to take action where there are serious horse welfare concerns.

See below the suggested changes, to the addition to Article 241 in the FEI Jumping Rules: 4. The President of the Ground Jury (or in the absence of the President of the Ground Jury from the Ground Jury box, the Ground Jury Member designated by the President of the Ground Jury to take over the running of the Competition in their absence) may, in their sole discretion, ring the bell (or instruct another Ground Jury Member to ring the bell) to eliminate an Athlete/Horse combination while a round is ongoing if the President of the Ground Jury (or their designee) decides that it would be contrary to the principles of horse welfare to allow the combination to continue the round.

The decision to eliminate is final and not subject to appeal or protest.

It is necessary a clear definition of the cases leading to elimination.

NF CAN

Canada disagrees with this article and feels that the elimination of a rider mid-round with no appeal or protest is unfair for the riders.

NF NED

We agree we the proposal of the FEI.

NF USA

The USA NF understands the Jumping Committee wanting to include the proposed language and fully supports the FEI's desire not to compromise on the welfare of the horse during competition. However, there is significant concern that even with proper training and

education that it will be challenging to ensure that the rule is enforced fairly and uniformly across officials. Unfortunately, there have been recent examples of officials interpreting Rules differently.

The USA NF also considers the Ground Jury already have authority to Eliminate an athlete under 241.3.26.

The USA NF supports the SWE wording but perhaps there needs to be further clarification. As an aside, Article 241.2 might need reviewing.

FEI feedback

The Jumping Committee was not in favour of making any changes to the proposed wording. There are too many cases that could lead to such an elimination and it is not deemed possible to list them all. If this new rule appears to be problematic in its implementation during 2023, it could be reviewed for 2024.

Blood on the horse's flanks, mouth <u>or nose</u> should always lead to Elimination. The chances of a nose bleed being a symptom of pulmonary haemorrhage is too big to ignore and should be checked by a veterinary. **This rule should also be added to the rules of all the other disciplines.**

Explanation for Proposed Change

This change in Art, 251 of the Jumping Rules has been made to reflect the request from several National Federations to amend the newly introduced rule of Annex V which has proven to be problematic in its implementation. Athletes who are invited in addition to the normal quota to fill up the stables will be allowed to take part in Longines Ranking competitions.

Proposed Wording on 6 July 2022

For all other Events including CSIOs definite entries must be made within the deadlines indicated below; other deadlines for NFs to indicate their intent to participate may be requested by the NF/OC in the Schedule.

Definite entries must be made by the date mentioned in the Schedule. This date may not be earlier than four weeks prior to the beginning of the Event and later than four days preceding the beginning of the Event. These represent the final selection of Athletes and Horses that will travel to the Event. The definite entries may not exceed the number listed and represent the final selection of Athletes and Horses that may participate in the Event, except if the maximum number of Horses that may be entered (based on the number of Athletes invited multiplied by the number of Horses allowed per Athlete) has not been reached at the closing of entries, the OC may invite additional Athletes. without the right to participate in Longines Ranking Competitions. Any Athlete so invited is ineligible to participate in all Longines Ranking Competitions at the Event, including if the Athlete will have qualified for a Longines Ranking Competition through one or more non-Longines Ranking Competition(s). Any Athlete so invited whose name appears in the results of a Longines Ranking Competition will earn no Longines Ranking points and will be disqualified retroactively from the Competition. If the Grand Prix or Competition with the highest prize money of the Event, if it is not the Grand Prix, is not a Longines Ranking Competition, and no qualification system for the Grand Prix or Competition with the highest prize money is foreseen in the Schedule, the OC may not invite such additional Athletes in excess of the maximum number of starters allowed to take part in the Competition concerned as established in the Schedule. Refer also to JRs Annex V: CSI Invitation Rules.

Explanation for Proposed Change

This change had been implemented following some discussions which had taken place several years ago and had been deferred to the latest full revision. As many manufacturers already have jackets with piping at other places than around the collar, this newly introduced rule has proven to be problematic in its implementation and the Jumping Committee is in favour of taking the added wording out.

Proposed Wording on 6 July 2022

Art. 256.1.5 Civilians are required to wear the uniform or clothing approved by their NF, a jacket, white or light fawn breeches, black or brown boots. Other dark coloured boots may be approved at the discretion of the FEI; boots may have one contrasting colour only, around the top, heel and/or toe. Boots must have a heel. Shirts may have long or short sleeves and must have a white collar; long-sleeved shirts must have white cuffs. A white tie or choker must be worn. Competition jackets may be any colour and must have outward facing buttons. If the jacket has a collar it must be a lapel collar which may be the same colour as the jacket or a different colour. Piping of any colour is allowed around the collar only. Jackets without a collar are allowed providing the shirt collar and tie are visible when the jacket is closed. If a jacket is not worn (refer to Art. 256.1.3 for exceptions due to weather), shirts must have sleeves; either short or long sleeves are permitted.

With the proposed changes in Annex VIII of the Jumping Rules which include taking out special qualifying competitions and following the discussions during the 2022 Sports Forum, the Jumping Committee wishes to introduce and additional FEI invitation (wild card) at Events for the purpose of obtaining a Certificate of Capability for the Olympic Games.

Proposed Wording on 6 July 2022

The FEI has the right to allocate an invitation to two Athletes for CSI2*/CSI3*/CSI4* events and one athlete for CSI5* events. The FEI invitations are included in the quota for compulsory invitations established under Section 1.1. The level of the nominated athlete must be of the required standard for the Event in question. OCs must accept the entries of Athletes to whom the FEI has allocated an FEI invitation. For CSI3* Events that are on the list of qualifiers for the Olympic Games published on the FEI website, the FEI has the right to allocate an additional-third FEI invitation to an Athlete attempting to earn a Certificate of Capability for the Olympic Games. The additional FEI invitation for Athletes attempting to earn a Certificate of Capability for the Olympic Games is not included in the overall quota of Athletes invited at the Event. This Athlete will be allowed to participate in all Competitions in addition to the number of Starters allowed providing the Athlete fulfils any qualification or participation requirement (for example, if the competition is a Grand Prix, providing the Athlete has completed, with their Grand Prix Horse, the initial round of at least one FEI Competition (according to Art. 261.4.4) prior to the Grand Prix). The FEI invitations are included in the quota for compulsory invitations established under Section 1.1. The level of the nominated athlete must be of the required standard for the Event in question. OCs must accept the entries of Athletes to whom the FEI has allocated an FEI invitation.

Explanation for Proposed Change

If an OC can fill up empty stables, this prevents a financial loss. Until last year, additional competitors could be invited under the condition that a qualifier for the Grand Prix was scheduled. In light of this, the rules were revised so that OCs are allowed to invite additional Athletes, but without the right to participate in Longines Ranking competitions, if the maximum number of Horses allowed to be entered has not been reached at the closing date of entries.

Unfortunately, the new rule means that those who can enter at this stage do not have the chance to qualify for Longines Ranking competitions, which in general are the competitions with higher prize-money.

It should be ensured that the OC can decide which Athlete shall be the replacement for an Athlete who was admitted via the "normal" quota (an entry system issue). That way, an Athlete who initially had a "filling stables up" invitation can be the replacement for a "normal" invitation and thus does have the right to participate in Longines Ranking competitions.

Or, if the above is a consequence that was not wanted or was underestimated, we should return to the previous wording of the 2021 rules.

OCs will be permitted to invite a limited number of additional Athletes without the right to participate in Competitions counting for the Longines Ranking if, at the closing of entries, the maximum number of Horses that may be entered has not been reached. If the Grand Prix, or the Competition with the highest prize money of the Event, if it is not the Grand Prix, is not a Longines Ranking Competition (e.g. if at a CSI2* the prize money offered for the Grand Prix does not meet the minimum required for a Longines Ranking Competition), and no qualification system for the Grand Prix or Competition with the highest prize money is foreseen in the Schedule, the OC may not invite such additional Athletes in excess of the maximum number of starters allowed to take part in the Competition concerned as established in the Schedule. These additional Athletes are not taken into consideration for the calculation of the percentages of Athletes to be invited under Sections 1-3.

We appreciate the changes made. However, in the meantime, after we had made the proposal that has now been supported by the Jumping Committee, the entry system has been developed further so that now it is possible to distinguish between the originally invited riders/horses and those who were invited later to fill up the stables. With the implementation of the possibility that athletes for the small/medium tour can be marked-up, the following alteration should be possible.

Thus it is guaranteed that OC will have the full quota for all Longines Ranking competitions.

If the Grand Prix, or the Competition with the highest prize money of the Event, if it is not the Grand Prix, is not a Longines Ranking Competition (e.g. if at a CSI2* the prize money offered for the Grand Prix does not meet the minimum required for a Longines Ranking Competition), and no qualification system for the Grand Prix or Competition with the highest prize money is foreseen in the Schedule, the OC may not invite such additional Athletes in excess of the maximum number of starters allowed to take part in the Competition concerned as established in the Schedule. These additional Athletes (apart from those who fill up the quota under section 1 - 3) are not taken into consideration for the calculation of the percentages of Athletes to be invited under Sections 1-3.

Explanation for Proposed Change

Many years ago minimal prize money and entry fee was decoupled from the conversion rate of Swiss franc to Euro, US Dollar,... and linked to the consumer price index and inflation. We understand that the entrée fee is not increasing every year a little amount, as the minimal prize money does, but we believe it is time to increase the maximal entry fee amounts due:

- all the extra Biosecurity measurements an OC needs to take from 2021 on, due to EHV1 outbreak, gives lots of extra cost to an organiser (extra quarantine stables, extra stewards, extra veterinarians,...)
- Consumer price index in Belgium has increased by 18,32% in the last 8 years, inflation was 7,59% in 2021 only.

 This means that all cost for organisers have increased in the last years by more than 20%.
- Every year the minimal prize money in increasing linked to the consumer price index and the inflation, every few year, the entry fee should also increase with the same %, with rounded amounts.

An increase by minimum € 100 seems logic to us, if you see the increase of Consumer price index and inflation so we propose that maximal entry fee becomes

IT WOULD BE CORRECT TO APPLY ENTRY FEES IN PROPORTION TO THE NUMBER OF RIDERS COMPETING AND THE PRIZE MONEY OFFERED.

THIS IS THE IJRC's comment and proposed wording:

As mentioned by OCs and as requested by them the conversion rate was applied after the meeting held in London in April 2021, with the FEI, the IJRC and the Organizers..

This involved stating the prizemoney in local currencies and no longer in Swiss francs in approved schedules.

At the time a Conversion rate was introduced to the significant disadvantage of the riders (what was used was an exchange rate established at 1.33 compared to the real one of 1.20) reducing prizemoney by -8.3%

Having linked prize money to the inflation index is unfortunately, annulled by an exchange rate that is significantly damaging to riders.

Entry fees, which forbade all extra fees, were established at €350 including VAT.

In establishing Entry Fees, Equestrian Organizers, would therefore like to consider the Belgian Inflation index (currently 7.9%) which is one of the highest in Europe.

While as far as increasing prizemoney is concerned the Swiss index, the lowest in the world has always been taken into account.

If the official Belgian inflation and cost-of-living indexes, mentioned by the Equestrian Organisers, were to be taken into account, it would therefore be correct to also take this index into account for both Entry Fees and prizemoney and also use official bank exchange rates.

Furthermore, as far as CSI 1*2* are concerned, increased expenses will be an additional burden for many breeders, YR, and coming up riders, who will no longer be able to afford to present their horses, seriously penalising the agricultural breeding sector.

The initial agreement concerning CSI and CSIO Requirements, it had been established that entry fees should include all tax to be applied to horses and TVA, with the exception of MCP fees, and all additional fees were forbidden. In the course of the years the following additional fees were added:

VAT from 10 to 19% Electricity from 40 to 70 euros Manure removal 40 € Parking from 50€

This has raised Entry fees from $350 \in \text{to a total of } 678 \in \text{ with an increase of } 95\%$.

It is IJRC's opinion that the entire equestrian sector should try and limit costs.

One must also take into account that in addition to entry fees established by FEI Regulations, taxes are increasingly often added that do not comply with FEI rules (pay cards, tables, administrative tax etc.).

Such fees affect above all YRs and coming up athletes who deserve to be able to afford to compete in sport that respects meritocracy.

The increase of the entry fee and of the costs, which are already expensive for Central and Southern Europe, will become unaffordable for the whole of Easter Europe, where the sport is currently undergoing promising development.

The IJRC understands the organizers' problems and believes a consultation is necessary.

NF GER

We are in line with the FEI feedback that this issue needs more consultation and should not be decided in a rush.

NF ITA

We definitely do not agree to an increase on the entry fee maximum amounts.

NF NED

We definitely don't agree with the proposal to increase of the entry fee. Although fees might not have increased in the past years, athletes are confronted with extra cost that are growing exponentially. A rider is not only paying the entry fee for a show, but is confronted with all kinds of extra costs like electricity for the truck, parking fees, manure disposal, EADCMP Fee, etc. and those cost are still growing. We can only agree to a higher fee if those cost include all the extra's that are now charged separately.

SWE NF

The SWE NF do not agree to an increase of entry fee. The cost of competing has risen significantly in recent times due to inflation etc.

FEI feedback

In 2017 it was agreed with all relevant stakeholders that minimum prize money and the maximum entry would evolve according to the inflation rate. This has been applied for the prize money but it has been omitted for the maximum Entry Fees. In order to make the necessary corrections it was decided to increase the maximum entry fees, as stated in Annex VI. 2 for Europe in 10% of its amount.

Annex VIII Qualification Procedure for Olympic Games, World and Continental Jumping Championships

- 1. Except for the Olympic Games Athletes and Horses are not required to qualify as combinations.
- 2. For the Olympic Games, Athletes/Horses must achieve the minimum eligibility requirements (MER) between 1 January of the year preceding the Olympic Games until the closing date for nominated entries, or a date established by the FEI. Refer to the FEI Regulations for Equestrian Events at Olympic Games for the qualification procedure for the Olympic Games.

[...]

3.8. For the avoidance of doubt, Athletes and Horses that need to achieve a minimum score in the first round of more than one Grand Prix, FEI World Cup™ or in the first or second round of more than one Nations Cup Competition at selected CSI3*, CSI1*/2*/3*-W / CSIO1*/2*/3*-W or CSIO3* and CSIO4* Events in order to earn a Certificate of Capability (paragraphs 3.5.1 and 3.3.6.1 above) may count the results obtained in the respective Grand Prix/FEI World Cup™ Competition towards the overall total of minimum results required. For example, Athletes and Horses with a score of zero penalties in the first round of one FEI World Cup™ Competition at a selected CSI1*/2*/3*-W Event and a score of zero penalties in the first round of a Grand Prix Competition at a selected CSI3* Event and a score of zero penalties in the first or second round of a Nations Cup Competition at a selected CSIO3* Event are considered to have fulfilled the minimum requirements for earning a Certificate of Capability.

[...]

8. In exceptional circumstances, if an NF can demonstrate that it has not been possible for its Athlete(s) to obtain invitations to Events in order to have sufficient opportunity to qualify as above, it may request the FEI for permission a special qualifying Competition to be organised for their Athlete(s), to which the FEI will send a foreign assessing delegate (Foreign Judge) at the expense of the NF topreside over the Competition; permission for a special qualifying Competition may be granted by the Jumping Committee. If the NF seeking permission for a special qualifying Competition requests that it be held outside its own country, for example if the Athletes concerned are based elsewhere, the NF must submit the request for the special qualifying Competition through the host NF. Special qualifying Competitions must be held at a CSI or a CSIO, following the last Competition of the Event, and must be run in accordance with the following FEI protocol.

The OC must inform the FEI of the exact dimensions of the outdoor arena (and any fixed elements) in order for the course plan to be designed. The OC must appoint an FEI Course Designer to build the course.

The FEI will appoint a Technical Delegate.

The FEI will appoint an international (foreign) judge to preside over the Competition.
The FEI will appoint an FEI Veterinarian to perform a horse inspection prior to jumping.
An FEI Steward must be present to carry out the usual duties of an FEI Steward including, but not limited to, the boot and bandage control.

In addition to the above an EADCMP test may be carried out on participating horses. An exact time must be established for the special qualifying Competition.

The Competition must be open to Athletes from other NFs and shall consist of one round. All costs for the special qualifying Competition will be at the requesting NF's expense, or will be shared among participating NFs if other NFs have entered Athletes needing the opportunity to achieve the MER.

The FEI will select an FEI Course Designer to design the course plan which must comply at least with the minimum dimensions and technical requirements outlined under the mandatory requirements for selected Nations Cup, Grand Prix and FEI World Cup™ Competitions in Art. 4 of this Annex; the course plan must be sent to the FEI Director Jumping for approval.

The FEI will provide the course plan to the Course Designer appointed by the OC on the morning of the special qualifying Competition.

Special qualifying Competitions that do not meet the above requirements will not be validated.

Athletes/Horses scoring four Penalties or less in this round will be considered to be qualified. The Foreign Judge, appointed by the Jumping Committee, will advise the FEI on the granting of Certificates of Capability.

4.4 Number of teams in the second round

The second round is open only to the ten best teams based on the total Penalties incurred by the best three Athletes of each nation in the first Competition and the best three Athletes per team in the first round and those teams placed equal tied on Penalties for 10th place. Before the ten best placed teams and those placed equal for 10th place begin their second round, all individuals and team members not qualified for the second round may take part in a second round qualifier for the third Competition. There must be a break of at least 30 minutes between the second round qualifier and the second round of the Team Final. For the North American combined Championships for Juniors and Young Riders, the following applies:

The second round of the Team Final is open only to the six best placed teams and those teams placed equaltied on <u>Penalties</u> for the sixth place following the first round of the Team

6.1 Running

This Competition consists of two different rounds A and B each judged under Table A not against the clock without a jump-off. In case of equality of Penalties for the first, second and/or third place in the overall classification of the Individual Championship, there will be a jump-off against the clock.

Qualified to participate are the top 60% of the Athletes (including those placed equaltied for the last qualification place) according to the cumulative Penalties over the first and the second qualifying Competitions, providing 60% of the Athletes is not more than 30 Athletes. The number of Athletes permitted to participate must not be less than 15, unless 60% of the Athletes is less than 15, and not more than 30.

They Athletes must have taken part in the first qualifying Competition (completed or not) and have completed the second Competition (without having been eliminated or without retiring). If, for any reason, one or more of the qualified Athletes are unable to start, they will not be replaced by followers.

All Athletes who complete Round A go forward to Round B. The Penalties in the two rounds are added.

The Athletes will be invited to inspect the course of Round B.

6.1.1. For the North American combined Championships for Juniors and Young Riders, the following applies:

Qualified to participate in the first round of the Individual Final are the 25 best placed Athletes (including those placed equal<u>tied</u> for 25th place) of each Category according to the cumulative Penalties of the first and second Competitions.

Qualified to participate in the second round of the Individual Final are the 15 best placed Athletes (including those placed equal for 15th place) of each Category.

3. Team Athletes not completing the first or second round of the Team Final receive 20 Penalties more than the worst placed team Athlete who has finished that particular round. If the Athlete concerned had obtained more Penalties before being eliminated or retiring than the worst placed team Athlete having completed the Competition, 20 Penalties will be added to the number of Penalties they had obtained at the time of being eliminated or retiring.

6.3.1. This Competition is run over two rounds, identical or different, with the same degree of difficulty in the second round, according to Table A not against the clock with a jump-off against the clock in case of equality of Penalties for first, second and/or third place in the overall classification for the Team Championship.

6.5.1. This Competition consists of two different rounds A and B each judged under Table A not against the clock.

Qualified to participate are the top 60% of the Athletes (including those placed equaltied for the last qualification place) according to the cumulative Penalties over the first and the second Competitions, providing 60% of the Athletes is not more than 30 Athletes. The number of Athletes permitted to participate must not be less than 15, unless 60% of the Athletes is less than 15, and not more than 30. However, all Athletes with equal Penalties for the last qualification place are allowed to participate in the Individual Final even if the number of starters would then be more than 30.

7.3 If the Championship is held during concurrently with a CSI the OC may allow the Athletes participating in the Championship to take part with different Ponies in the Competitions of the CSI. 3.5 Number of teams in the second round

The second round is only open to the ten best teams following the first qualifying Competition and the first round of the Team Competition and those teams $\frac{\text{placed equal}}{\text{tied on Penalties}}$ for 10^{th} place.

This Competition consists of two rounds A and B, each judged under Table A, not against the clock, with a speed of 350 m per minute.

Qualified to participate are the top 60% of Athletes (including those placed equal tied for the last qualifying place) according to the cumulative Penalties over the first and second qualifying Competitions, providing 60% of the Athletes is not more than 30 Athletes. The number of Athletes permitted to participate must not be less than 15, unless 60% of the Athletes is less than 15, and not more than 30. We do not agree with the addition of the language "unless 60% of the Athletes is less than 15". These age categories are still growing in North America and restricting the Final to 60% could result in disadvantaging the already limited opportunities for Youth athletes to compete and complete a Championships and /or could result in the Final Competition having so few athletes it will not feel like a proper competition.

At the very least, we propose that the 60% rule can be waived with the permission of the FEI Jumping Department in instances where there is a valid request.

As per the Medical Committee's recommendations, in case of a fall of an Athlete at any time in the Competition arena, in the practice arena or elsewhere within the grounds of the Event, the Athlete must be checked by the Event's medical service (or by a medical doctor if the medical service is not available) before they may be permitted to take part in the round in progress or in the next round or Competition at the Event.

The consequences are therefore the same. As to whether the Athlete is "Eliminated" or considered as "Did not Start" or no sporting consequences (after the crossing line for example) depends on the timing of the fall and is a field of play/sporting consideration.
